Floor coverings on a warranty deadline



The Flooring Industry Training Association (FITA) has entered into a Memorandum of Understanding (MOU) with 24 leading South African Flooring Manufacturers, Distributors and Contractors to announce that from 1 July 2018 product warranties on poor installation, carried out by installers not accredited by FITA, will no longer be honoured.

As a minimum, the Head Installer must have registered individually with FITA and hold a Construction, Education and Training Authority (CETA) accredited qualification. This is currently the National Certificate: Installation of Floor Coverings (NQF1). It covers limited flooring types, which the MOU clause is also restricted to. However, FITA is actively working with CETA and industry to create a revised curriculum which will be ready in 2018. At that point, the MOU will be extended to all flooring types contained therein.

"FITA's role in the industry is to encourage and facilitate the recognition, upskilling and training of installers for the benefit of all sectors of the flooring industry" says Tandy Coleman, Chairman of FITA. "This is done by utilizing the funding provided by CETA and industry players who register with FITA. We are available to assist contractors and installers to either enrol at a FET college or participate in the Recognition of Prior Learning (RPL) accreditation process to ensure they are compliant by July next year."
